Overall Progress Narrative:

In 2024 Qtr 1, OCD continued making progress on the implementation of the following programs:

- Restore20 Louisiana Homeowner Program;
- RLHP20 Flood Insurance Assistance Program;
- RLHP20 Interim Housing Program;
- Soft Second Mortgage Program
- Middle-Market Loan Program
- Neighborhood Landlord Rental Program
- Permanent Supportive Housing Program
- Rapid Rehousing Program
- Resilient Mixed Income Gap Funding Program
- HMGP Global Match Program
- Nonfederal Share Match Program
- Resilient Communities Infrastructure Program
- Small Business Loan and Grant Program

Furthermore, OCD worked with its local, State, regional partners, and stakeholders to assess outstanding unmet recovery needs, as well as develop and amend programs to address those unmet needs. The progress on the individual programs comprising the Flood grant is as follows:

Restore20 Louisiana Homeowner Program

The Restore Louisiana Homeowner Assistance survey opened on Feb. 1, 2022 and closed August 31, 2023. Application deadline was 10/31/2023. Any application submitted past that date in which a damage assessment was not performed prior to 12/31/2023 are not guaranteed reimbursement without receipts and proof of payment.

- Phase 1 on May 11, 2022
- Phase 2 3 on Aug. 24, 2022
- Phase 4 5 on Nov. 28, 2022
- Phase 6 on Dec. 15, 2022

As of 06/30/23, 27,901 surveys have been submitted. 18,323 homeowners were determined to be Phases I – VII. 10,980 environmental reviews were completed and 10,975 respondents have been invited to submit their application. 5,590 applications have been submitted. 3,187 grant awards have been offered to homeowners, amounting to \$257,220,853.53. Of those, 1,618 homeowners have executed their grant agreements, obligating \$130,811,724.18.

As of 9/30/2023, funds expended provided repair, reconstruction, replacement, and/or reimbursement to disaster impacted homeowners with AMI less than or equal to 80%.

• Application Submission Deadline of 10/31/2023 has passed. Applications submitted past 10/31/2023 may not be guaranteed reimbursement without receipts due to federal timeline requirements

• 25,659 environmental reviews have been completed, representing 99.8% of the 25,716 homeowners in Phases I – VII.

 25,646 homeowners, from Phases I – VII, have been invited to start an application. 17,824 applications have been submitted

There has been a total of 7,221 grant awards offered to homeowners totaling \$514,343,532.16.
 Of those, 4,430 homeowners have closed on their grant agreements, obligating \$345,846,011.00.
 1,510 Housing projects have been completed to date.

As of 03/31/2024 - 39,323 surveys were submitted and 25,713 environmental reviews were completed. 25,701 respondents have been invited to complete application and 25,345 applications have been submitted. 10,776 grant awards have been offered to homeowners, amounting to \$476,962,525.00. Of those, 5,813 homeowners have executed their grant agreements, obligating \$ 320,924,551.51. 2,131 Housing Projects have been completed.

Restore20 Louisiana Homeowner Program – Solution 4

The Solution 4 option of the Restore Louisiana omeowner Assistance Program is a voluntary real property acquisition program. The buyout program is designed to move residents of damaged properties located in floodways or other high-risk areas out of harm's way to areas of lower risk. Awards are calculated using the fair market value of the damaged property minus any duplication of benefits. Expenditures for the quarters ending 6/30/2023 and 9/30/2023 were for Activity Delivery Costs. As of December 31, 2023, all expenditures were for activity delivery. As of March 31, 2024, all expenditures were for activity delivery.

RLHP20 Interim Housing Assistance Program

As different federal funding programs are tapering off and/or no longer available to reduce or eliminate interim housing costs paid to some program participants, the RLHP provides assistance related to additional eligible rental or mortgage expenses, for up to 20 months, provided the household is at or below 120% AMI and is an active applicant within the RLHP. As of June 30, 2023,



the program has assisted 48 total active RLHP20 homeowners with temporary housing assistance while their homes are being repaired or reconstructed, with \$239,308.42 in assistance paid to date. Of these, 45 applicants were temporarily housed in a hotel; 3 applicants were housed directly to a rental unit. The obligated total funding for the total 130 approved IHA participants is \$660,169.18. (218 total Applicants)

As of September 30, 2023, payment of rental or hotel lodging for eligible applicants with AMI less than or equal to 80% while their repair/reconstruction projects are underway through State managed construction until the home is complete and deemed safe/habitable.

As of December 31, 2023, 1021 applications have been completed and submitted by homeowners. Of these, 557 applications have been approved. 294 grantees have executed grant agreements totaling \$3,491,892.51 in funds obligated, of which \$2,610,778.06 has been paid to date. As of March 31, 2024, the program has received 1662 applications for interim housing assistance while their homes are being repaired or reconstructed. Of these, 439 applicant have executed IHA

while their homes are being repaired or reconstructed. Of these, 439 applicant have executed IHA grant agreements with \$5,449,582.04 in assistance paid to date and \$6,620,665.86 in obligated funds.

RLHP20 Flood Insurance Assistance Programspan style="font-size: 10.0pt;" data-mce-style="font-size: 10.0pt;"> As of June 30, 2023, 182 applications have been completed and submitted by homeowners. Of these, 129 applications have been approved with 79 grant agreements totaling \$127,979.59 in premiums obligated, of these, 51 policies totaling \$67,232.69 have been paid.

As of September 30, 2023, funds expended for purchase of one-year term flood insurance premium for eligible applicants with AMI less than or equal to 80%.

As of December 31, 2023, the program has received 855 applications for assistance. Of these, 462 applicants have been approved totaling \$666,343.25. Of these, 209 policies were purchased totaling \$284,049.69.

As of 03/31/2024., the program has received 1291 applications for assistance. Of these, 828 applicants have been approved totaling \$1,115,838.37. Of these, 407 policies have been purchased totaling \$544,935.16.

Soft Second Mortgage Program

The Soft Second Mortgage Program provides homeownership assistance to first time low- and moderate-income homebuyers by providing soft second mortgages and closing cost assistance to acquire site-built homes outside the Special Flood Hazard Area. This program helps eligible renters to become homeowners in the relatively lower risk areas of storm-impacted parishes, thereby alleviating the rent burden potentially faced by some eligible applicants.

As of December 31, 2023, \$315,680.00 was expended on activity delivery and to assist seven (7) families to obtain homeownership.

As of 3/31/2024, expenses totaling \$18,499.91 were for activity delivery. The remaining \$252,100 were for down payment assistance and closing cost assistance.

Middle-Market Loan Program

The Middle-Market Loan Program (MMLP) will provide gap financing to support the rehab and/or construction of muli-family buildings in impacted parishes that serve a range of household incomes, with the goal of achieving below-market rent affordability for LMI households.

That range of "middle-market" rents also allows participants to embed units with deeper affordability into higher-income areas, which provides good, stable housing in high-opportunity areas to low-income families and encourages socioeconomic integration into communities. Projects funded through MMLP will require OCD standards of safety, environmental sustainability, and resilience to storm hazards, which will not only ensure the longevity and quality of those projects but will also positively influence design and building standards for Louisiana's affordable housing industry. \$3,900 in expenditures this quarter were for Activity Delivery. The \$27,998.75 in funds expended as of quarter ended 9/30/2023 were for NOFA program

development.

As of December 31, 2023, all funds disbursed are for program delivery. The NOFA was published on August 2023. Deadlines for applications was December 2023. Awards are to be announced by end of January 2024.

As of 3/31/2024, There are currently two (2) MMLP projects. Denham Townhomes and YMCA. Both projects are currently in construction process. Denham Townhomes is 61% completed as of Q1 and YMCA construction has just started in Q1.

Rental Restoration and Development (RRDP)

The Neighborhood Landlord Rental Program will offer funding for applicants to rehabilitate existing housing units or construct new affordable housing units. NLRP will also revitalize communities impacted by Hurricanes Laura, Delta, Ida and/or the May 2021 Severe Storms by reducing the blight of damaged properties as it redevelops them into affordable rental housing. Permanent Supportive Housing Program

The Permanent Supportive Housing Program (PSHP) model is a proven, evidenced-based best practice housing model that results in long-term improved outcomes for people whose disabilities would otherwise severely compromise their housing and economic security. PSHP achieves these outcomes in two ways:

• Creates affordable rental housing units in a non-institutional setting linked with flexible community-based supportive services. This approach leads to reduced utilization of emergency room services and other high-cost health / social service interventions, and to cost savings that outweigh spending required to provide the supportive services.

• Creates a program network coordinated at the State level rather than at the provider level, systematizes access to a pipeline of affordable housing units, and opens up opportunities to



leverage Medicaid funding and disaster recovery funds for long-term housing solutions. This approach emphasizes the long-term resilience of both the individuals who benefit from supportive housing and the institutional networks that serve them.

Rapid Rehousing Program

The State has established a model of Rapid Rehousing for households following disasters. The Rapid Rehousing Program (RRH) is based on an effective solution to address the needs of persons at risk of becoming homeless by providing a combined solution of affordable housing and support services that help households to be self-sufficient. This includes preventing homelessness whenever possible by rapidly rehousing people when homelessness is imminent and providing 'wrap around' services that stabilize the cost of housing and supports self-sufficiency for the household. Resilient Mixed Income Gap Funding Program (PRIME)

The Resilient and Mixed Income Piggyback Program (PRIME) provides funding for the construction of guality, affordable multifamily rental developments.

PRIME requires that all new units incorporate disaster resilience measures to provide better outcomes in a major storm or rain event. The program's policies have the stated goal of providing more social and physical security in the rental and housing market and encouraging innovation in building practices to lessen future storm impacts to property and residents.

With the additional proposed resources from PRIME, the State can ensure that rental units created to address rental needs in impacted areas will also protect low-income rentals from future disasters. In addition to being required to meet the programmatic LIHTC requirements, applicants eligible for PRIME assistance are required to develop new, quality, affordable rental housing using higher standards and innovative practices in order to lower the risks from storm and hurricane-related impacts. The funding will provide developers with the opportunity to use workable approaches to resilient housing (such as, but not limited to elevated structures/mechanicals, building materials/technologies, power generation, topography and landscaping, retention/detention ponds, etc.) toward development of nearly two dozen properties, which are substantially more likely to fare better in major storms than existing properties in similar locations. 26 Applicants have been selected and will now proceed towards closing award loans. All quarterly spending was for Activity Delivery.

As of December 31, 2023, twenty-seven (27) applicants have been selected and 8 awards have closed.

As of 3/31/24, there are currently two (2) Fast Gap projects. Government Corridor and Nathan Village. Government corridor is 100% completed and ribbon cutting was in Q1. Nathan Village is 91% completed and expected completion date being in Q2.

HMGP Global Match Program

The State will work with eligible applicants and other State agencies to identify the most efficient means of implementing a global match program for approved FEMA's Hazard Mitigation Grant Program (HMGP) projects.

Nonfederal Share Match Program

Investments in infrastructure repair and rebuilding in areas impacted by Hurricanes Laura, Delta, Ida and/or the May 2021 Severe Storms helps to secure investments in housing recovery and bolsters confidence in communities continuing to rebuild. Without assistance to meet the State and local match requirements, the infrastructure and resources typically provided by State and local governments will be severely at-risk, as the State and local governments will be required to either a) forgo assistance from FEMA PA or b) divert funding needed for other community needs toward meeting the match requirements. The State will dedicate funds to offset the burden of the nonfederal share match requirements faced by State and local entities and jurisdictions. Resilient Communities Infrastructure Program

The State will create a program for eligible subrecipients to revitalize designated commercial districts damaged by Hurricanes Laura, Delta, Ida and/or the May 2021 Severe Storms. Encouraging economic opportunities, while supporting the recovery of commercial areas, is essential to ensuring that commercial tenants, customers and jobs are restored. By facilitating the return of commercial districts and businesses to profitability, jobs will be created or retained within the community and residents will continue to have access to the products and services they need within their local community.

Small Business Loan and Grant Program

The State will administer a lending program for disaster-impacted small businesses for nonconstruction related expenses. The State will enter into subrecipient agreements with implementing partners including local community development organizations (non-profit organizations, community development financial institutions, local credit unions, and other eligible organizations). In the event the State is unable to identify local community development organizations that can serve the entire impacted area, the State may issue awards directly to small businesses that meet the program criteria.

The 2020 Restore Small Business Loan program expenditures, \$35,616, are for Activity Delivery per a task order for Cohn Reznick. The following Lenders have been selected to administer the 2020 Restore Small Business Loan Program: New Corp, South Central Planning, New Orleans Regional Loan Corp, and North Delta Planning.

The \$51,815.00 in funds expended as of quarter ended 9/30/2023 were for administrative activities. As of December 31, 2023, the four lenders administering loans for this Program are South Central Planning, New Corp, Regional Loan Corp, and North Delta. The application intake ended on December 31, 2023. However, due to the high demand, the application intake was extended to June 30, 2024. Each Lender was given the opportunity to submit a request for an extension knowing that an approval would be based on performance. Regional Loan Corp and North Delta declined the extension. South Central Planning was approved and New Corp's submittal for an



extension is currently under review by OCD Management. Out of the \$96,150,714.00 allocation, \$2,404,302.91 was expended in the 4th quarter of 2023. These expenditures includes 10 loans for \$2,264,547.09, \$75,527.82 in activity delivery costs, and \$64,228.00 for vendors. Each Lender is currently processing their applications that were submitted into IGX by December 31, 2023. As of 3/31/2024, two of the four lenders of the 2020 Restore Louisiana Small Business Loan Program have closed 47 loans totaling \$9,186,079.19. All lenders submitted 22 Activity Delivery Costs draw requests totaling \$289,520.70. A total of \$64,140.50 was paid to the authorized vendors for administration. A total of \$9,539,740.39 was expended in this quarter. The program budget is \$96,150,714.00 and a total of \$11,806,736.34 (12.28%) has been expended to date.

The Resilient and Mixed Income Piggyback Program (PRIME) provides funding for the construction of quality, affordable multifamily rental developments.

PRIME requires that all new units incorporate disaster resilience measures to provide better outcomes in a major storm or rain event. The program's policies have the stated goal of providing more social and physical security in the rental and housing market and encouraging innovation in building practices to lessen future storm impacts to property and residents. With the additional proposed resources from PRIME, the state can ensure that rental units created to address rental needs in impacted areas will also protect low-income rentals from future disasters.

In addition to being required to meet the programmatic LIHTC requirements, applicants eligible for PRIME assistance are required to develop new, quality, affordable rental housing using higher standards and innovative practices in order to lower the risks from storm and hurricane-related impacts. The funding will provide developers with the opportunity to use workable approaches to resilient housing (such as, but not limited to elevated structures/mechanicals, building materials/technologies, power generation, topography and landscaping, retention/detention ponds, etc.) toward development of nearly two dozen properties, which are substantially more likely to fare better in major storms than existing properties in similar locations.
