3. You must satisfy all requirements for the position, including State Civil Service minimum qualification requirements for this position.
4. Prior to employment, all male employees age 18-25 must be registered with Selective Service (www.sss.gov)
5. Louisiana participates in the Federal E-Verify program. You must provide original or certified documents for identification and employment eligibility: social security card, birth certificate, and a government-issued photo ID.
6. You must agree to receive wage and compensation payments via direct deposit through electronic funds transfer to a bank, savings and loan, or credit union authorized by the DOA. You must also comply with international ACH Transaction (IAT) rules.
7. You must agree to allow recoupment of any funds received in error, without the necessity of any action other than prior notification to you of the amount paid in error.
8. You must acknowledge receipt of Form SSA-1945 (Federal Social Security Protection Act of 2004, Public Law 108-203), which explains that earnings from this job will not be used to determine eligibility or to calculate the amount of potential future Social Security benefits.
9. Per Act 264 of the 2013 Regular Session: if employed in an unclassified position earning more than \$100,000 annually, you must maintain a valid Louisiana driver's license, and all vehicles titled in your name must be registered in Louisiana.
