- 3) MEDICAID STATUS REPORTS ARE TO BE PRESENTED BEGINNING NO LATER THAN OCTOBER 15, 2024 AND MONTHLY THEREAFTER.
- 4) ALL MEETINGS ARE SCHEDULED TO BEGIN AT 9:30 A.M.; HOUSE COMMITTEE ROOM 5, AS POSSIBLE.
