




#### FY 2023 - 2024 Recommended State General Fund Expenditures by Functional Area State General Fund only (Totals \$11.44 billion)




FY 2023 - 2024 Recommended Federal Funded Expenditures by Functional Area Federal Funds only
(Totals \$23.75 billion)








### FY 2023 - 2024 Recommended Discretionary Expenditures by Functional Area All Means of Finance (Including Double-Counts)
